California Consumer Privacy Act Notice

1. About this Privacy Notice

Pursuant to the California Consumer Privacy Act of 2018 (“CCPA”), U.S. Energy Development Corporation is providing this California Consumer Privacy Act Notice (“CCPA Notice”). This CCPA Notice applies solely to California consumers, and is effective January 1, 2020. Terms used but not defined shall have the meaning ascribed to them in the CCPA.

2. Personal Information Collected

We collect the following categories of personal information as indicated with a check mark below

A. Identifiers such as a real name, alias, postal address, telephone or mobile contact number, unique personal identifier, online identifier, Internet Protocol address, email address and account name.	✓
B. Personal information as defined in the California customer records law, such as name, contact information, education, employment, employment history and financial information.	✓
C. Characteristics of protected classifications under California or federal law.	✗
D. Commercial information, such as transaction information, purchase history, financial details and payment information.	✓
E. Biometric information, such as fingerprints and voiceprints.	✗
F. Internet or other electronic network activity information, such as browsing history, search history, online behavior, interest data, and interactions with our and other websites, applications, systems and advertisements.	✗

J. Education information subject to the federal Family Educational Rights and Privacy Act, such as student records.	✓

U.S. Energy Development Corporation does not sell personal information.

We collect this personal information from you in the form of the Subscription Document.

We use this information to fulfill our obligations under the securities laws and to provide income and tax related information to them.

3. Personal Information Disclosed

We may use this personal information to operate, manage, and maintain our business, to provide our products and services, to communicate with you, and to accomplish our business purposes and objectives, including, for example, using personal information to produce tax information, provide our investors access to our web portal and perform identity verification, perform accounting audit, and other internal functions; comply with law, legal process, and internal policies; maintain records; exercise and defend legal claims; and to fulfill our legal obligations under the securities and exchange laws.

U.S. Energy Development Corporation does not sell personal information to third parties within the scope of the application of the CCPA.

4. Consumer Rights

You have the right to request that we disclose to you (i) the categories of personal information we collected about you and the categories of sources from which we collected such information; (ii) the specific pieces of personal information we collected about you; (iii) the business or commercial purpose for collecting personal information about you; and (iv) the categories of personal information about you that we shared or disclosed and the categories of third parties with whom we shared or to whom we disclosed such information in the preceding 12 months. You also have the right to request that we delete personal information we collected from you subject to certain exceptions.

You also have the right to not be discriminated against in pricing and services because you exercise any of your rights under the CCPA. U.S. Energy Development Corporation does not offer financial incentives or price or service differences to consumers in exchange for the retention or sale of a consumer's personal information.

5. How to Make a Request

You may make a request for the disclosures or deletion described above through our website at usedc.com or by emailing us at investorrelations@usedc.com.

You may be required to submit proof of your identity for these requests to be processed as a verifiable consumer request. We may not be able to comply with your request if we are unable to confirm your identity or to connect the information you submit in your request with personal information in our possession. You may designate an authorized agent to make a request on your behalf subject to proof of identity and authorization.

We will respond to your request consistent with the CCPA, which does not apply to certain information, such as information made available from government records, certain data subject to the Fair Credit Reporting Act (FCRA), Gramm-Leach-Bliley Act (GLBA) and certain other laws, and where its application is preempted by, or in conflict with, federal law or the United States or California Constitution.
